# Chapter **1**

## **Product Summary**

The Compaq StorageWorks Fibre Channel Storage Hub 12 is an active 12-port hub for Fibre Channel-Arbitrated Loop (FC-AL) storage clusters, server clusters, and networks, providing gigabit speed storage connectivity, modular network scalability, and option network management.




Figure 1-1. Compaq StorageWorks Fibre Channel Storage Hub 12

## **Features**

- Expandability and Performance supports 12 GigaBit Interface Converter, GBIC ports with parallel and serial identification protocols
- Flexibility adheres to the ANSI FC-AL standard
- Intelligent Port Control provides multiple data checks without affecting performance
- Spatial Economy takes up only 1U of rack space
- Ease of Use provides port-bypass circuitry flexibility and simplifies central wiring management

## **Functions**

The Compaq StorageWorks Fibre Channel Storage Hub 12 continuously monitors the serial data and automatically configures an FC-AL network. Adding valid FC-AL nodes with ANSI-compliant cables is truly a plug-andplay task. Loop nodes that are missing or inoperative are detected, and the data is automatically routed to the next operational port and node in the loop.

The hub is transparent to the protocol. It does not consume any FC-AL addresses and so is not addressable by an FC-AL port. Because of the intelligent signal detection tests, only valid Fibre Channel devices will be connected to a loop when using the hub. If an FC-AL node were to transmit invalid Fibre Channel data, the node would be taken off the loop automatically. Examples of node behavior that will result in a bypass state are transmission of invalid characters, absence of frames, and invalid signal amplitude.




Figure 2-1. Hub 12 installed in a Compaq rack

## **Compaq Rack Warning**

## **Hub Warning and Precaution**

WARNING: To reduce the risk of personal injury or damage to the equipment:

- Do not disable the power cord grounding plug. The grounding plug is an important safety feature.
  - Plug the power cord into a grounded (earthed) electrical outlet that is easily accessible at all times.
  - Disconnect power from the hub by unplugging the power cord from either the electrical outlet or from the back of the hub.

**CAUTION:** Protect the hub from power fluctuations and temporary interruptions with a regulating uninterruptible power supply (UPS). This device protects the hardware from damage caused by power surges and voltage spikes and keeps the system in operation during a power failure.

## Installation Sequence

Below is a brief summary of the steps you will follow to install Compag StorageWorks Fibre Channel Storage Hub 12:

- 1. Unpack the Hub 12 option kit and verify contents.
- 2. For a rack installation, attach the rack mounting hardware (page 2-4) and install the hub into the rack (page 2-8). Then proceed to step 4.
- 3. For a desktop installation, install the four rubber feet (page 2-12). (This step is for desktop installations only.) Proceed to step 4.
- 4. Connect the cables to the hub and perform a unit self test.

## **Rack-Mounting or Desktop Installation**

The Compaq StorageWorks Fibre Channel Storage Hub 12 can be installed in a rack or on a desktop; however, this guide is primarily directed toward rack installations. Rack-mounting installations require an industry standard 19-inch electronic enclosure rack or a Compag 19-inch electronic rack. The rack installation procedures provided in this guide are for the Compaq rack. Desktop installations require a flat, level surface and the attachment of four rubber feet on the bottom of the chassis.


When installing the hub, allow at least 6 inches of clearance at the rear panel and at the sides of the chassis for proper air circulation.

## Installing the Rack Mounting Hardware for a Compaq Rack Installation

### Locating the Rack Mounting Hardware



Locate the rack mounting hardware in your shipping box:

- Rack mounting rails
- **2** Chassis slide rails
- Screws for rails and 1U faceplate
- Air baffles
- **6** 1U faceplate

## Identifying the Rack Mounting Rails and the Chassis Slide Rails

Two rack mounting rails (long rails) and two chassis slide rails (short rails) are used to support the hub in a Compaq rack. The chassis slide rails, which are attached to the hub chassis, slide into the rack mounting rails, which are attached to the front and the rear of the rack.




Figure 2-3. Chassis slide rail ① and the rack mounting rail ②

### Attaching the Rack Mounting Rails to the Rack

WARNING: To reduce the risk of personal injury or damage to the equipment:
 Extend the leveling jacks to the floor. And ensure that the full weight of the rack rests on the leveling jacks.
 Ensure that the stabilizing feet are attached to the rack in a standalone rack installation.
 Couple racks in multiple rack installations.
 Extend only one component at a time. A rack may become unstable if more than one component is extended for any reason.

- 1. Locate the two rack mounting rails.
- Attach a mounting rail to the front of the rack, using two M6 x 1.0-12L Phillips screws ①. One screw is for the top rail hole and one screw is for the bottom rail hole.




Figure 2-4. Installing the rack rails

- 3. Carefully align the mounting rail with the rear rack frame.
- Secure the back end of the rail to the back of the rack with two M6 x 1.0-12L Phillips screws ②. One screw is for the top rail hole and one screw is for the bottom rail hole.
- 5. Attach the second rail to the rack.
- 6. After both rails have been attached to the rack, the slide rails are ready to be attached to the hub.

### Attaching the Chassis Slide Rails to the Hub

- 1. Locate the two chassis slide rails.
- 2. To attach the rails, remove the two M6 x 1.0-6L Phillips screws at the rear of the unit, as shown in the figure below, and replace them with M6 x 20-6L Phillips screws, provided with this kit.




Figure 2-5. Attaching chassis slide rails

## Installing the Hub into the Rack

1. After installing the rack mounting hardware, carefully align the hub's chassis slide rails with the rack mounting rails and begin sliding the hub into the rack.



**CAUTION:** Be sure to keep the component parallel to the floor when sliding the component rails into the rack mounting rail. Tilting the component up or down could result in damage to the rails.

2. Continue to slide the hub into the rack until the latches on the front of the slide rails engage with their alignment holes on the mounting rails. You will know they are engaged when you hear a "clicking."




Figure 2-6. Loading the Hub in the rack

After sliding the hub in place, the front of the hub chassis will sit approximately 6 inches (15 cm) from the front of the rack.




Figure 2-7. Hub loaded in the rack

3. Install the bottom air baffle.




Figure 2-8. Installing the bottom air baffle

4. Install the top air baffle.






Figure 2-9. Installing the top air baffle



5. Install the 1U faceplate with two M6 x 1.0-12L Phillips screws.

After the hub is installed in the rack, you are ready to connect the Multi-Mode Fibre Channel Cables and to power up the unit.

# Installing the Rubber Feet for a Desktop Installation

If the unit will not be installed in a rack, you will need to attach the four rubber feet provided in the shipping box. These feet stabilize the base of the unit and minimize damage to any surface on which the unit rests.

Turn the hub over and install one rubber foot in each corner of the unit. After the rubber feet are installed, you may place the hub on a flat, level surface and connect the cables. See "Connecting the GBIC Module and the Fibre Channel Cable," later in this chapter.




Figure 2-12. Installing the four rubber feet - desktop installations only

## **Identifying the Rear Panel Components**




Figure 2-13. Identifying the rear panel components

The rear panel of the hub provides the LEDs, connectors, and button you will need to complete the rack installation. See Figure 2-13 and Table 2-1 to identify the components on the rear panel. See Chapter 3, "Troubleshooting," for using the rear panel components when troubleshooting the hub.

# Connecting the GBIC Module and the Fibre Channel Cable to the Hub

The hub has 12 modular, gigabit-per-second user-configurable interface ports. These 12 ports are compliant with the GigaBit Interface Converter, GBIC specification. Standard GBIC Modules are hot-pluggable. To connect an FC-AL to the hub, you will need to install a standard GBIC Module followed by a Fibre Channel cable into one of the 12 ports. See the documentation supplied with the module and the cable for detailed installation instructions. If you need to obtain GBIC Modules or Fibre Channel cables, contact your local Compaq Reseller or Authorized Compaq Service Provider. See "About This Guide" for information on locating your nearest Compaq representative.

1. Gently insert one GBIC Module into any available port on the hub, until you feel the module click into place. The module is keyed to prevent you from inserting the module incorrectly.

**CAUTION:** To reduce the risk of damage to the equipment, do not use excessive force when inserting the GBIC Module.




Figure 2-14. Installing a GBIC module

2. Plug one end of a Fibre Channel Cable into the GBIC Module installed in step 1. (The other end of the cable connects to an active FC-AL device.) The GBIC Module and the Fibre Channel Cable are keyed to prevent you from installing the cable incorrectly.




Figure 2-15. Installing a Fibre Channel cable

- 3. Continue to install GBIC Modules and Fibre Channel Cables for all active port connections.
- 4. Provide support, with user-supplied tie-wraps, for the installed cables so as not to have a bend radius of less than 3 inches.
- 5. Route the cable(s) to prevent damage from sharp edges or from being crushed by nearby equipment.

# Connecting the Power Cord and Performing a Self Test

After installing the Fibre Channel cables to the hub, you are ready to supply power and run a system check.

1. Plug the AC power cord into the hub, then into a grounded AC outlet. The unit will begin to run self test, which lasts 15 to 60 seconds. During self test, all LEDs will turn on. After the unit completes the self test, the Power LED stays on, the Fault LED turns off, and the port LEDs assume their operational state.




Figure 2-16. Checking the power LED and the fault LED

2. Verify that the top green GBIC LEDs illuminate on all ports where GBIC Modules are installed.




Figure 2-17. Checking the GBIC LEDs

3. Verify that the bottom amber Bypass Port LEDs illuminate on all connected ports that are not participating on the loop. For example, Port 2 in the figure below is not participating in the loop. Ports that do not detect valid FC-AL links will be bypassed automatically. To be a valid link, both ends of the cable must be connected to active, powered, FC-AL devices.




Figure 2-18. Bypass Port 2 LED illuminates when port is not participating on the loop

## **Troubleshooting Guidelines**

If there is a problem accessing an FC-AL device connected to the hub, the source of the problem can be the FC-AL device, the hub, the host, or any of the connections between the host and device. See the *Compaq StorageWorks Fibre Channel Troubleshooting Guide* to troubleshoot the loop. Use this chapter to troubleshoot the hub.

You can follow the steps outlined below to investigate the problem from the most likely to the least likely cause.

- 1. Inspect the cabling between the hub and attached FC-AL devices. Check for loose, dirty, broken, or bent cabling and connectors. Cables should latch into position with an audible "click."
- 2. Inspect the hub LED indicators for apparent problems. See "Troubleshooting with the LEDs and the Reset Button."
- 3. Check the GBIC Modules to ensure they are inserted properly.
- 4. Make sure that both ends of each Fibre Channel cable are connected to active, powered, FC-AL devices.

# Troubleshooting with the LEDs and the Reset Button

If you are having problems with the hub, find the symptom in Table 3-1 that best describes what you are observing, and attempt the solution that seems appropriate. Where more than one solution is possible, the most likely solution is listed first.

# Performing a Self Test after the Initial Power-Up

One of the quickest methods to check the ports and the hub is to run a self test. Self test will check those ports with active loop devices connected. For example, to check all 12 ports, you will need to have active loop devices connected to all 12 ports. See Chapter 2, "Overview of Installing the Compaq StorageWorks Fibre Channel Storage Hub12," for cabling instructions.

1. If the hub is not powered up, plug the AC power cord into the hub, then into a grounded AC outlet. If the hub is powered up, press the Reset Button on the rear of the unit. The unit will run self test, which lasts 15 to 60 seconds. The unit passes self test if the Power LED turns green and the Fault LED turns off.

**CAUTION:** Resetting the hub disrupts the network, which can impact performance. This will not normally corrupt data on disk drives attached to the hub.




Figure 3-1. Checking the power LED and the fault LED

2. Verify that the green GBIC LED illuminates on all of the ports with a GBIC Module.




Figure 3-2. Checking the GBIC LEDs

3. Verify that the Bypass LED illuminates on all connected ports not participating on the loop. For example, Port 2 in the figure below is not participating in the loop. Ports that do not detect valid FC-AL links will be automatically bypassed. To be a valid link, both ends of the cable must be connected to active, powered, FC-AL devices.




Figure 3-3. Bypass port LED illuminates when port is not participating on loop.

# Appendix **A**

## **Electrostatic Discharge**

To prevent damaging the system, be aware of the precautions you need to follow when setting up the system or handling parts. A discharge of static electricity from a finger or other conductor may damage system boards or other static-sensitive devices. This type of damage may reduce the life expectancy of the device.

To prevent electrostatic damage, observe the following precautions:

- Avoid hand contact by transporting and storing products in static-safe containers.
- Keep electrostatic-sensitive parts in their containers until they arrive at static-free workstations.
- Place parts on a grounded surface before removing them from their containers.
- Avoid touching pins, leads, or circuitry.
- Always be properly grounded when touching a static-sensitive component or assembly.

## **Grounding Methods**

There are several methods for grounding. Use one or more of the following methods when handling or installing electrostatic-sensitive parts:

- Use a wrist strap connected by a ground cord to a grounded workstation or computer chassis. Wrist straps are flexible straps with a minimum of 1 megohm ± 10 percent resistance in the ground cords. To provide proper ground, wear the strap snug against the skin.
- Use heel straps, toe straps, or boot straps at standing workstations. Wear the straps on both feet when standing on conductive floors or dissipating floor mats.
- Use conductive field service tools.
- Use a portable field service kit with a folding static-dissipating work mat.

If you do not have any of the suggested equipment for proper grounding, have an Authorized Compaq Reseller install the part.

# Appendix **C**

## **Power Cord Set Requirements**
